## 14. Recommendation for Professional Service Agreement with Biogas Engineering

Commissioner Rigney was under the impression that Edison was coming in to do some improvements and from Edison's point of view that they would take care of the issue. He was a surprised to see a request to have Biogas do a study as well.

Manager Olds said that there were two separate issues. What SCE will be installing this calendar year is called a voltage regulator. VVWRA has issues with the amount of voltage coming into the facility. This is one problem. The other problem is that currently this equipment and the way it's configured, when there are little blips, it shuts down the entire facility. Staff believes that this is a problem related to the interconnection agreement and Edison has informed VVWRA that they are willing to entertain adjusting this but they want the study to justify the numbers. They want to make certain that it is consistent with the interconnection agreement that is in place and that the engineering had been done to ensure the legitimacy of it. They have also requested that a third party perform the testing and report back to them.

#### 18. Presentation: FY 2018-2019 Budget

Manager Olds stated that this budget is contingent upon receiving funding from CalOES and FEMA. They are currently holding a little over \$3.7 million of VVWRA funds in retention. In order for VVWRA to meet debt service and other obligations this year, those funds are required. If that does not occur, VVWRA will be dipping into restricted SRF loan reserve funds that will make that payment. VVWRA would then have to notify the State that VVWRA is no longer in compliance with our debt covenants and will need to renegotiate our debt. The second item that needs to be noted is that VVWRA will build the Desert Knolls Wash Interceptor Replacement Project and intend to begin construction in the fall of this year. The reason this project must be completed is that this line is currently compromised. It will cost VVWRA approximately \$1.5 million to build this project. That pipeline carries 1.15 Million gallons per day from the Town of Apple Valley, if that line were to fully break that is a \$10 a gallon fine that equals \$11.5 million a day in fines. VVWRA wants to ensure that does not happen and so this project must move forward.

Manager Olds stated that currently staff is using Operator 10 software that was implemented in 2006 and it no longer works. The software company has not kept the product up to date. In 2006 - 2008 Manager Olds said it use to take him 30 minutes to complete a monthly monitoring report. Now, with the software being outdated and not syncing with other systems, staff has informed him that the reporting required by the State takes days and multiple staff to accomplish. Staff has spoken to the laboratory and this is the software that the lab uses and staff feels that it will help simplify the transition. Manager Olds said that he would like to get back those 20 plus staff hours that currently go in to preparing a monthly report and given to other issues.
