STAFF RECOMMENDATION

It is recommended that the Board of Commissioners adopt Resolution 2024-09 to amend and adopt 2024 local guidelines for implementing the California Environmental Quality Act.

PREVIOUS ACTION(S)

As required by state law, the Commissions amends and adopts the local guidelines for implementing the California Environmental Quality Act on an annual basis. This item addresses that obligation.

BACKGROUND INFORMATION

The California Environmental Quality Act ("CEQA"), as contained in Public Resources Code sections 21000 et seq., is California's most comprehensive environmental law. It requires all public agencies within the state to evaluate the environmental effects of their actions before they are taken. CEQA also aims to prevent significant environmental effects from occurring as a result of agency actions by requiring agencies to avoid or reduce, when feasible, the significant environmental impacts of their decisions.

To this end, CEQA requires all public agencies to adopt specific objectives, criteria and procedures for evaluating public and private projects that are undertaken or approved by such agencies.

As a result, the Victor Valley Wastewater Reclamation Authority's Local CEQA Guidelines have been revised and amended to reflect recent changes to the State CEQA Guidelines, the Public Resources Code and relevant court opinions.

RESOLUTION 2024-09

A RESOLUTION OF THE VICTOR VALLEY WASTEWATER RECLAMATION AUTHORITY AMENDING AND ADOPTING LOCAL GUIDELINES FOR IMPLEMENTING THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (PUB. RESOURCES CODE §§ 21000 ET SEQ.)

WHEREAS, the California Legislature has amended the California Environmental Quality Act ("CEQA") (Pub. Resources Code §§ 21000 et seq.), the Natural Resources Agency has amended the State CEQA Guidelines (Cal. Code Regs., tit. 14, §§ 15000 et seq.) and the California courts have interpreted specific provisions of CEQA; and

WHEREAS, Public Resources Code section 21082 requires all public agencies to adopt objectives, criteria and procedures for (1) the evaluation of public and private projects undertaken or approved by such public agencies, and (2) the preparation, if required, of environmental impact reports and negative declarations in connection with that evaluation; and

WHEREAS, the Victor Valley Wastewater Reclamation Authority must revise its local guidelines for implementing CEQA to make them consistent with the current provisions and interpretations of CEQA and the State CEQA Guidelines.

NOW, THEREFORE, the Victor Valley Wastewater Reclamation Authority ("VVWRA") hereby resolves as follows:

<u>SECTION 1</u>. The VVWRA adopts the "2024 Local Guidelines for Implementing the California Environmental Quality Act," a copy of which is on file at the offices of VVWRA and is available for inspection by the public.

SECTION 2. All prior actions of VVWRA enacting earlier guidelines are hereby repealed.

STAFF RECOMMENDATION

It is recommended that the Board of Commissioners authorize the general manager to use user fee reserve funds to pay SoCal Biomethane 50% of the cost for the digester one dome replacement and pressure relief valve modification for an amount not to exceed \$140,000.

PREVIOUS ACTION(S)

None

BACKGROUND INFORMATION

As previously discussed with the board, on February 28, 2024, the gas storage dome on digester one ruptured after being over-pressurized. Following the failure, VVWRA staff met with the SoCal Biomethane team to discuss options to complete the repairs. It was determined that both organizations had some culpability in the accident that occurred. The necessary funds to make the repairs were allocated in the spring of 2024 with the plan to complete the repairs before the end of the fiscal year. As part of the negotiated terms to make the repairs, VVWRA purchased the new dome last fiscal year.

Repair option discussions identified the root cause of the over-pressurization to be a bad design on the pressure relief valve piping, VVWRA worked with SoCal Biomethane, JR Miller engineers, and W.M. Lyles to redesign the pressure relief valve piping. After finalizing the design, the decision was made to split the material and labor costs between SoCal Biomethane and VVWRA

for this redesign work. This repair was also scheduled to be completed last fiscal year, but design and material lead times did not allow this work to progress as scheduled.

The unused funds were moved into user fee reserves at the end of the fiscal year. Because the fiscal year ended the funds we had allocated for the project are now within the reserve fund and the VVWRA Board must approve the use of those funds. SoCal Biomethane will contract W.M. Lyles to perform the work and VVWRA will reimburse SoCal Biomethane for our 50% share once the work is completed.
